### **Assisting Individuals in Crisis & Group Crisis Intervention (GRIN)**

**Many consider this foundational course to be essential in understanding and responding to stress and trauma**

#### **Course Description:**

**This 3-day course combines ALL of the content of ICISF's Assisting Individuals in Crisis & Group Crisis Intervention courses.**

**Crisis Intervention is NOT psychotherapy; rather, it is a specialized acute emergency mental health intervention which requires specialized training. As physical first aid is to surgery, crisis intervention is to psychotherapy. Thus, crisis intervention is sometimes called "emotional first aid". Designed to present the core elements of a comprehensive, systematic and multi-component crisis intervention curriculum, this course will prepare participants to understand a wide range of crisis intervention services for both the individual and for groups. Fundamentals of Critical Incident Stress Management (CISM) will be outlined and participants will leave with the knowledge and tools to provide several group crisis interventions, specifically demobilizations, defusings and the Critical Incident Stress Debriefing (CISD). The need for appropriate follow-up services and referrals when necessary will also be discussed.**

**This course is designed for anyone in the fields of Business & Industry Crisis Intervention, Disaster Response, Education, Emergency Services, Employee Assistance, Healthcare, Homeland Security, Mental Health, Military, Spiritual Care, and Traumatic Stress.**

### **Pastoral Crisis Intervention Three Day Class: 9/11-13/2022**

**Many people in crisis experience challenges that require knowledge of how the emotional and spiritual intersect.**

#### **Course Description:**

**Pastoral Crisis Intervention (PCI) may be thought of as the integration of psychological crisis intervention with pastoral perspectives and resources. This newly revised course (previously known as Pastoral Crisis Intervention I & II) is designed to train participants in the use of psychological trauma and intervention techniques. This program does not provide instruction on spirituality or theology. Additionally, more specific advanced concepts and current field applications where pastoral crisis intervention will be covered.**

**Chaplains, pastoral counselors, mental health professionals, ministers, and anyone interested in the use of faith-based resources in healing or enhancing their skills in responding to individuals in crisis should find this course of interest.**

### **Morning Course Description:**

**Zero to Sixty-Career Survival and Emotional Wellness** is a seminar will educate through “boots on the ground” front line experiences and will provide responders and/or their loved ones or professionals with a clear picture on why these helping professions often lead to destructive and unhealthy lifestyle habits. *2 the Rescue* will demonstrate how the inability to manage the cumulative stress from daily exposures to adrenaline and trauma negatively affects safety, decision-making and one’s ability to remain ethically solid. First responders, their “work family” and their loved ones will be armed with tools to manage the everyday unique stressors and will be able to recognize the warning signs for chronic and post-traumatic stress and suicidal behavior. Participants will learn realistic, simple and successful methods to help rescue the rescuers! This program is for all first responders, Fire, EMS, dispatchers, law enforcement, nurses, social workers and any other mental health professionals that provide a service to others.

**Your Peer Support Team is up and running. That's great! Now the real work starts. Training and communication within your team, and among leaders and support partners is critical to achieving growth and to success. Teams need buy in from different groups, which should include family members, city and township management, command staff, Union leadership, EAP and, perhaps most importantly, your peers.**

**Whether you are just launching a team, or you've been operating for a while, this course will help and encourage you. This training is designed as an open discussion format. *2 the Rescue* will lead the dialogue on a range of developmental topics, encouraging course participants to raise specific questions on what is and isn't working in sustaining their peer support team.**

### **Understanding the First Responder's Cultures: For Mental Health Staff**

**One Day Class: 9/11/2022**

**If you want to provide mental health help to first responders you have to understand who they are, how they think, and what they face on the job.**

#### **Course Description:**

All Mental Health professionals know that we need to understand the cultural setting of their clients to provide the most effective interventions. This may be especially true for working with First Responders. For the purposes of this training, First Responders are identified as those individuals who work as: Dispatchers, Law Enforcement Officers, Correctional Officers, Firefighters, and Emergency Medical personnel. While many issues/stressors are common all of these professions, some are more unique to specific groups. This course identifies the cultures of each profession and their unique stressors. First Responders may have a variety of life issues including marital problems, family issues, depression, substance abuse struggles, PTSD, etc. Mental health professionals need to understand the unique stress of first responder professions and how these may impact their non-professional lives in order to offer the most effective help in an ethical and non-biased manner.

This class will provide information about first responders' cultures and opportunities for discussion regarding adapting our clinical approach to meet the needs of first responders.

**If you've completed introductory CISM training (Group Crisis Intervention or Assisting Individuals in Crisis & Group Intervention, also known as GRIN) this class will help you to refine your skills and knowledge**

#### **Course Description:**

Designed to provide participants with the latest information on critical incident stress management techniques and post-trauma syndromes, the Advanced Group Crisis Intervention builds on the knowledge base which was obtained through the Group Crisis Intervention course and/or in publications. At the conclusion of this course, participants will have been exposed to specific, proven strategies to intervene with those suffering the ill effects of their exposure to trauma. Emphasis will be on advanced defusings and debriefings in complex situations. This course is designed for EAP, human resources and public safety personnel, mental health professionals, chaplains, emergency medical services providers, firefighters, physicians, police officers, nurses, dispatchers, airline personnel and disaster workers who are already trained in the critical incident stress debriefing format. It will also be useful for those working extensively with traumatized victims for various walks of life. This course requires previous training and experience.

#### **Course Description:**

**After learning the CISM techniques it is important to get the experience in using and maintaining the skills necessary to do quality interventions. This course has been designed to provide participants with direct application and practice of skills of crisis intervention techniques. The course emphasizes a broadening of the knowledge base concerning critical incident stress management interventions as well as the practice of each application. Participants will learn some training techniques and activities that they might use to assist their teams in additional skill building. This course has been developed for Employee Assistance Programs, human resources staff, public safety personnel, mental health professionals, chaplains, paramedics, firefighters, physicians, police officers, nurses, dispatchers, airline personnel and disaster workers to increase mastery and confidence in the skills learned during the CISM core courses.**

The RAM Center provides a recreational retreat with rustic lodging, modern meeting spaces, and recreational activities on the shore of beautiful Higgins Lake.
